Doggie Style'z Pet Grooming and Boarding Contract

This contract between the Doggie Stylz Pet grooming and Boarding kennel(kennel) and the pet owner (Owner) whose signature appears on Page 1.

Kennel agrees to exercise due and reasonable care, and to keep the kennel premises sanitary and properly enclosed. The boarding pet(s) is to be housed in clean, safe quarters and to be fed properly and regularly.

Owner agrees to the following:

1. To pay the kennel the set rate, per pet/per day, for any and all services rendered.
2. Owner will be charged for a full day of boarding on the arrival date, regardless of the hour of drop-off.
3. Owner will be charged for a full day if not picked up by 9:00 a.m. on the scheduled pick-up day this time applies to Saturday and Sunday and Monday weekday Tues-Friday is anytime between 9 and 5 however anything after 11a.m. will be charged for a full day.
4. If pet is found to have fleas or ticks, pet will be bathed with a flea shampoo, at the expense of the owner.
5. All charges incurred shall be payable, by cash, check or credit upon pickup.
6. To provide all vaccinations records as required, and to inform Kennel of any medical conditions. By signing the Agreement and leaving pet with Doggie Stylz owner certifies to the accuracy of all info given about said pet(s). Doggie Stylz reserves the right to deny admittance to Owners pet(s) for any reason, at any time.
7. Owner specifically represents to Doggie Stylz Pet Grooming and boarding that to the Owners knowledge, the pet has not been exposed to any contagious diseases within a 30-day period prior to check-in. During the period of this agreement, Owner also agrees to notify Doggie Stylz pet grooming and Boarding of any known exposure of pet(s) to a communicable disease and hold pet out of attending Doggie Stylz until receiving written veterinary clearance.
8. In the event pet requires medical attention while in the care of Kennel, Kennel may engage the services of a veterinarian of its choosing ,administer medicine or give other attention to the pet(s) and expenses for such veterinary attention shall be payable by Owner.
9. Owner agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the Kennel, to include payment of costs for injury to staff or other animals, or damage to facility caused by pet.
10. It is expressly agreed by Owner and Kennel that liability shall in no event exceed the value of a pet(s) of the same species or the sum of \$400 dollars per animal admitted.
11. All Charges incurred by owner shall be payable upon pick-up of pet. Doggie Style'z pet grooming and Boarding shall have, and is hereby granted, a lien on the pet(s) for any and all unpaid charges resulting from services provided by Kennel. The Owner hereby agrees that in the event the charges are not paid when due, in accordance with this contract, of pet is not picked up within ten days of scheduled pick-up, Kennel may exercise its lien rights upon ten days 'written noticed given by Kennel to Owner, by certified Mail, to address shown on contract. Kennel may dispose of pet for any unpaid charges, at private or public sale, in the sole discretion of Kennel. Owner specifically waives all statutory or legal rights to the



contrary. If such sale shall not secure a price adequate to pay such costs, then Owner shall be liable to Kennel for the difference.

Any controversy or claim arising out of, or relating to this Agreement, or breach thereof, or as a result of any claim or controversy involving the alleged negligence by any party to this Agreement shall be settled in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by and arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of the award determines an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.

It is understood by the Kennel and Owner that all provisions of the Contract shall be binding upon both parties for this visit and for all subsequent visits.

4. If pet is found with fleas and ticks, pet(s) will be bathed in a flea shampoo, at the expense of the Owner.
5. All charges incurred shall be payable, by cash, check or credit upon pick-up.
6. To provide all vaccination records as required, and to inform Kennel of any medical conditions. By signing this Agreement and leaving pet with Doggie Style'z Pet Grooming and Boarding, Owner certifies to the accuracy of all info given about pet(s). Doggie Style'z Pet Grooming and Boarding reserves the right to deny admittance to Owners Pet(s) for any reason at any time.
7. Owner specifically represents to Doggie Style'z Pet Grooming and boarding that to Owners Knowledge, the pet(s) have not been exposed to any contagious diseases within a 30 day period prior to check-in. During the period of this agreement, Owner also agrees to notify Doggie Stylz Pet Grooming and Boarding of any known exposure of a pet to a communicable disease and hold the pet out of attending Doggie Style'z until receiving written veterinary clearance.

10. It is expressly agreed by Owner and Kennel that liability shall in no event exceed the value of Pet of the same species or the sum of \$400 dollars per admitted animal.
11. All charges incurred by the Owner shall be payable upon pick-up of pet. Doggie Style'z pet grooming and boarding shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from services provided by Kennel. The Owner hereby agrees that in the event the charges are not paid when due, in accordance with this contract, or pet is not picked up within ten days of scheduled pick-up, Kennel may exercise it's lien rights upon ten days of written noticed given by Kennel to Owner, by certified Mail, to address shown on contract. Kennel may dispose of pet for any unpaid charges, at private or public sale, in the sole discretion of Kennel. Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs, then Owner shall be liable to the Kennel for the difference.

Any controversy or claim arising out of, or relating to this Agreement, or breach thereof, or as a result of any claim or controversy involving the alleged negligence by any party to this Agreement shall be settled in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by and arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of the award determines an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.

It is understood by the Kennel and Owner that all provisions of the Contract shall be binding upon both parties for this visit and for all subsequent visits.
